"The Show Must Go On!"

In December, 2008, the Board of Directors of our COOP, the Baguio-Benguet Community Credit Cooperative (BBCCC), received an e-mail from then Director and Board Chairman/President Amado Jesus F. Cendaña, tendering his resignation "as member of the Board effective receipt of this letter". He further wrote that the Board may appoint his replacement as provided for in our COOP By-Laws. He said that during his stay in Florida, U.S.A., while on leave here at BBCCC starting after our Golden Anniversary Celebration on October 11, 2008, he received an advisory from the U.S. Citizenship and Immigration Services (USCIS) requiring him for his biometrics appearance on January 16, 2009, and it would take another couple of weeks, according to him, before he would know USCIS action on his petition. Hence, his resignation letter.

So, by the principle of succession, being the Vice-Chairman/Vice-President, I had to assume the responsibility of becoming the Chairman/President, until the reorganizational meeting of the Board of Directors within ten (10) days after the Annual General Assembly (AGA) on March 15, 2009. I consider it a great and a command responsibility with whatever happens during my incumbency, even though for a few months only, considering the many preparations to be done for the AGA.

But "The Show Must Go On (TSMGO)", as the saying goes. With the help of the officers, management, staff and concerned members and with the spiritual guidance of the Lord Almighty we can be successful. In fact, instead of appointing the seventh (7th) BOD member to fill up the vacancy, the Board decided to just wait for the AGA for the COOP members to elect the 7th Director. So, even with just six (6) members of the Board from mid-October 2008, to mid-March, 2009, TSMGO!

By the way, do you know the origin of the saying "The Show Must Go On"? There was the story of a clown who was performing on stage. Then news reached him that his son just died. But he said to himself, "The Show Must Go On!", so, even if he was crying in the inside, he had to laugh on the outside to let the audience also laugh, while performing his role as a clown. In the Philippine situation, if one cannot continue to perform his/her job or role to be done, and somebody else has to take responsibility, we say, "The Show Must Go On!" so as not to jeopardize the operations or activities to be implemented.

Anyway, I am surrounded with responsible, dedicated BODs, management, staff and members, and above all, the Divine Guidance is always sought for. These thoughts liberated me from fear of leading a COOP of 19,448 members (regular and associate) as of this writing.

To the new set of officers, my congratulations! (By the time this issue of our COOPSERVER will be released by the printing press and read by our members, we expect already a new set of officers.) Whatever responsibilities given to us, let us accept the challenge and work for the benefit of our Cooperative, the BBCCC, with the welfare of the members as a priority in our decision-making process.

In the Scholarship Program, the Foundation honored eleven (11) graduating scholars from different public high schools in Baguio and Benguet last March 20, 2009. They were treated to the traditional Graduation Lunch and were given their three hundred (P 300.00) graduation token in March 20, 2009.

In the support of the **Street Urban Working Children**, the Foundation gave to one hundred street children their grocery coupon worth P100.00 each representing the first quarter Accompanied by their parents, the children lost no time buying their toiletries (soap, shampoo, tootbrushes, etc.) from the Coop grocery.

The Foundation has adopted the *Panaghenga Park* at South Drive as its **community involvement and outreach**. Policy on Application for Positions and Appointment of BBCCC Officers

Hereunder are the policies on the application for and appointment to memberships in the ad hoc committees as recommended by a Committee of Dir. Nelson Gayo, Dir. Oscar Adversalo and Dir. Amparo Rimas and approved by the Board.

- The Board has the sole prerogative to make appointments.
- Should there be more than five (5) applicants, the BOD shall short list the same to five (5) applicants.
- An applicant must be a member in good standing prior to appointment.
- The appointee must have a fixed capital of no less than TWENTY THOUSAND PESOS (P 20,000.00) at the time of application.
- Except on the working Board policy, no two position shall be held simultaneously by any elective or appointive officer.
- An applicant must write his letter of intent and supply the following information:
 - day of the week and the time of his availability for coop work
 - his schedule of work either as employee or in the practice of his profession.
 - fill up the personal information attached.
- Must not be related to any member of the Board within the third degree or civil degree of consanguinity.
- Posting of vacancies and acceptance of application must be within the ten (10) days after the date of Board re-organization.
- Within five (5) days after the 10th day of filling of application, the Board shall select appointive officers and make the necessary appointment by and through the Chairman of the Board.
- A committee is composed of not more the two (2) members.
- Appointment is good for one (1) year and automatically expires on the day of the General Assembly, which ever comes earlier without
 prejudice of the Board revoking same for cause.
- During the selection process the Board may conduct an interview either individually or in group, if individually, interview must be conducted within the premises of BBCCC.
- Appointive officers must possess the necessary skills and competence pertinent to the work or needs of the particular committee.
- The RATA and/ or Honorarium of the appointive officer shall be in accordance with the coop's existing policies on the matter.
