BBCCC's Educational Programmes: Towards Members' Enlightenment and Empowerment

Education brings about enlightenment and with enlightenment comes empowerment. Through education, the person acquires the knowledge and understandings (cognitive), the skills and abilities (psychomotor), and the values and appreciations (affective) he needs to make enlightened decisions. Enlightenment equips him with the power to improve himself so that he may live a happy life.

The Baguio-Benguet Community Credit Cooperative regularly undertakes educational programs intended to educate, enlighten, and empower its officers, staff and general membership. These include conferences, seminars, training-workshops and study trips. Doubtless, all these translate to the individual's overall development and growth. The officer becomes a better leader; the administrative staff serves with commitment and dedication; and the members acquire a feeling of ownership and loyalty to the Cooperative.

Over the years, BBCCC has sustained a number of financial assistance schemes intended to make the cost of education affordable to the members. The educational loan has helped many a member and his family obtain an education. The testimonials found elsewhere in this issue attest to this. Even many so-called provident loans have been used to defray payment of tuition fees, purchase of books and other incidental school expenses such as uniforms, fare, rental, food, and the like.

Young adult savers enjoy a grocery loan privilege and it is observed that these young ones use it primarily for the purchase of school materials - paper, notebooks, pens - available at the BBCCC grocery.

A grocery assistance coupon as incentive for some 120 street children to attend school regularly has been the subject of an MOU between the City Government and BBCCC. Aptly called "Support a Child Project", this activity is being coordinated with the Office of the

City Social Welfare Development (OCWD). The children who have been certified as regular in their school attendance get from BBCCC a grocery coupon each month which they can exchange for items they need such as soap, toothpaste, canned goods, and others. The amount is modest but it can rightly be claimed that this has served as a great encouragement for regular class attendance of children who would otherwise easily keep to the streets rather than be in the classroom.

It depends on the movements' ability to develop, to manage itself efficiently, to exert political and public influence, to train its volunteers and staff as well, and use its numbers to best advantage. While many housing co-operatives have successfully met the immediate needs of their members for shelter, they must also broaden their commutment to helping themselves and others through co-operation.

The success and the growth of the housing co-operatives movement is linked to the ability to co-operate and unite at all possible levels. Success and growth depends on the ability to share and gain from each other's experiences. Beyond the interest of individuals and co-operatives, expansion of the movement should be the major objective. The challenge is to research, examine apply and build on every possible opportunity to go forward and meet the broader aims of co-operation in order to achieve workable housing schemes for our people.

COMMON BANK OF COOPERATIVES

(AND OF THE COMMON CO-OPERATORS)

The frontliners of coop development are telling us that the backbone of a successful cooperative movement is its centralized financial system. This system provides for credit guarantee system, deposit insurance, mutual support fund, liquidity management system, and other financial and related products for member cooperatives. The Rabobank Netherlands, the DZ Bank of Germany, Labour Banks of Japan, and the NACF of Korea, to name a few, are excellent models of such centralized financial systems. Countries with the system have enviably huge, progressive and sustainable cooperatives – be they credit unions, farmers marketing societies, co-housing cues, consumer stores, electric coops.

Primaries and federations support the system, give best efforts, and in turn use much-needed services which otherwise would not have been available nor affordable, with the common, grassroots co-operators ultimately enjoying the benefits. The Philippines, sad to say, has no such grand-scale sharing/pooling system, although there had been recorded several failed attempts to form one by government and by coop alliances.

BBCCC has long felt and pointed up the need of central finance facility bigger and more solid than the familiar Central Finance Facility (CFF) of PFCCO and its Leagues. Then, BBCCC did seek a real-big national consolidated coop bank capitalized, owned, operated, and patronized by *all* Pinoy coops, big and small. Now come renewed interests and revival moves among coop leaders. The idea of having an apex bank, a national bank or a central finance system for cooperatives has again been the subject of series of consultations and discussions in the cooperative sector. BBCCC has been there to express its views, and help build the appropriate common bank of all willing (and able) cooperatives.

After a series of consultations with coops and coop banks facilitated by the Philippine Cooperative Center (PCC) through its highly-spirited chairman, also Presidential Adviser on Cooperatives, Roberto "Obet" Pagdanganan (BBCCC's Atong Fernandez is vice chairman), three main options were identified for the centralized financial system:

- Option 1: Merger of existing cooperative banks into a national consolidated cooperative bank;
- Option 2: Formation of a consolidated cooperative bank with coops and coop banks as members and with government equity participation through SSS, GSIS, and other government institutions;
- Option 3: Land Bank of the Philippines (LBP) to serve as apex bank, serving as depository bank of coops and providing liquidity management and other financial services across participating coops.

The Task Force on the Cooperative Centralized Financial System (CCFS), consisting of LBP, PDIC, CDA, CUP, MSCB, NATCCO, PFCCO, NCM, and PCC, studied and proposed the features of the System, while a Technical Working Group drew the terms of reference for the conduct of a study to determine the viability of a national consolidated cooperative bank. Option 3 turned out to be the most viable, with the following short-listed features:

- An apex bank to manage excess liquidity of cooperatives. Here LBP will initially serve as the Apex Bank of the cooperatives
- Funds generated through savings in coops/coop banks will be used by the coops themselves
- · Credit guarantee system for loans
- · Deposit insurance system for cooperatives
- · Accreditation standards, training and education
- Coops/coop banks meeting the standards will serve as conduits for government development funds for agriculture, entrepreneurs
- Coops/coop banks will operate independently. Membership in the CCFS will be voluntary and subject to qualification standards

More owners project consultation meetings and refinement of the CCFS concept are scheduled: at PCC Manahan Hall on June 21, at CDA on June 28, at PCC on July 2, and then the National Coop Workshop and MOU signing by key players at Malacanang Palace on July 6, with no less than President GMA as special guest of honor. It appears that the CCFS will reach us ground feeders from the top. But BBCCC is tops, and has to realize early the considerable significance

BBCCC TIES UP WITH INTERNATIONAL COOPERATIVE ALLIANCE (ICA)

Even as BBCCC, like other coops throughout the country, awaits the land use conversion of its housing lot in Lubas, La Trinidad, Benguet, the Housing Committee has adopted the strategy of "doing what can be done while something cannot yet be done." Engineering plans and designs have been made for compliance with the requirements of Development Permit and Environmental Clearance Certificate. The CHIPS program goes on.

But something new has cropped up lately. For the second time this year, two foreign visitors from Sweden, namely, Rolf Trodin and Rolf Akeby, have visited BBCCC as representatives of the International Cooperative Alliance (ICA). They have been accompanied by the Head of NATCCO Housing Resource Center, Mr. Danny Consuegra. In at least two conferences participated in by BBCCC Board of Directors and Officers together with the Board of Directors and Officers of the SLU-SVP Housing Cooperative, the visitors described the housing scheme in Sweden, now termed as the ICA housing scheme after it has been accredited by the United Nations, as a model which may be imitated in other countries.

The ICA housing model has two types, the renting coop and tenants' owners coop. In the renting coop system, the Coop owns the land and building and a member merely rents a unit in the building. When the member wants to move, he gives up the unit to the coop. Based on a queuing system, another housing coop member will be asked to move to the unit.

In the tenants' owners coop, a member is a partowner of the coop by contributing a share of the cost of the building and operation, and gets from the coop a certificate of eternal living right in the unit. The tenant owner can sell the part-ownership right in the market as owner of the unit.

The Swedish visitors tried to persuade the participants on the merits of the ICA housing model and as a result the parties agreed to network and cooperate in an endeavor to propagate it or even pilot it in Northern Luzon. They even suggested that the best way to start is the creation of a new housing coop through the sponsorship of BBCCC and SLU-SVP. Accordingly, a Memorandum of Agreement is being prepared by the two coops to provide the mandate for the creation of the new housing coop.

The NATCCO Housing Resource officer likewise informed the two cooperatives that as a way of giving more concrete orientation to the Swedish type ICA housing scheme, there would be a yearly educational ICA sponsored trip to Sweden where some coop leaders, including those from BBCCC and SLU-SVP, will be invited. This year's delegate will be Atty. Ruben A. Corpuz, BBCCC Housing Committee Chair and President of the SLU-SVP Housing Cooperative. Incidentally, last year, the former President of the SLU-SVP Housing Cooperative, Ma. Asuncion B. Minglana, joined the first study tour to Sweden.

Rimas Mentor to 4th ACCU DE Course

Vice Chair Ampy Rimas was selected as mentor to the 4th Asian Development Education Course organized by the Asian Confederation of Credit Unions (ACCU) last June 9-14, 2002, with technical collaboration with the Credit Union Foundation of Australia (CUFA). The Philippine Federation of Credit Cooperatives (PFCCO) hosted the program. The venue was the

Development Academy of the Philippines at Tagaytay.

There were twenty-five (25) Credit Union leaders who participated in the DE, twelve of whom came from the neighboring Asean countries. Of these, two came from the Cooperative Credit Union League of Bangladesh Ltd.; three from the National Credit Union Federation of Korea (NACUFOK); two from the Credit Union League of the Republic of China; another two from the Telecom Credit Cooperative of Singapore. There was one participant from the Nepal Federation of Savings and Credit Union Ltd. (NESFSCUN). The rest of the participants came from the different primaries and leagues in the country.

The participants occupy high positions in their respective Credit Unions. One is CEO/President; four belong to the Board of Directors; nine are General Managers, twelve are Officers such as Auditor, Accountant, HRD Officer, Project Assis-

tant, Education Officer, etc.

The Development Education Program is a high level training for Credit Union leaders. Basically, it is a very intensive course involving not only a deep understanding of burning issues affecting the viability and growth of Credit Unions but also of enhancing Credit Union leaders' presentation skills. Understanding development issues will, hopefully, make the leader more appreciative of the value of his job and the important role he plays in building a strong financial Coop for his community.

The 25 graduates of 2002 4th Asian DE's join the 130 DE'S in Asia - 78 from the Asian DE and more than 50 from the

Australian DE.

Composing the mentors of the 4th Asian DE were: Mr. Grahame Mehrtens, International Development Manager of the Credit Union Foundation of Australia (CUFA); Mr. Bill Field, Deputy Chairman of Trustees, also of CUFA; Mr. Ranjith Hettiarachchi, Chief Executive Officer of the Association of Asian Confederation of Credit Unions (ACCU) Ms. Elenita V. San Roque, Manager, Member Services, also of ACCU; Ms. Maribel Gulay, Field Officer of the Philippine Federation of Credit Cooperative (PFCCO), and Amparo T. Rimas, Vice President and Chair of the Education and Training Committee, BBCCC.

Of her experience as Mentor, Ampy has this to say: "It was a great honor not only for me personally but for our BBCCC as well. To have selected one from our cooperative to assist in the training of coop leaders in Asia is indeed a great privilege. It was classroom work all over again for me - subject matter, teaching strategies, instructional aids, student - teacher interaction - made me nostalgic of my many years as Professor of Saint Luis University. It was interesting mentoring a highly heterogeneous group, cultural variations and language difficulties notwithstanding. I feel good and am grateful for the opportunity to be of assistance in the exciting work of development education in Credit Unions here in the country and in the neighboring Asian countries as well."

Option 2 minus yet "with government equity contribution through SSS, GSIS, and other government institutions" appears to be the *added*, perhaps *other* alternative pursued by bottom-to-top adherents. This has less government intervention but obviously the envisioned national and consolidated Coop Bank may take too long a time to build. Nonetheless, the Metro South Cooperative Bank (MSCB), one of the biggest if not the biggest coop bank in the country today, has much earlier adopted, and has been "slowly but surely" pursuing this self-reliant, consensual but long and winding route. The dream is convergence of cooperators, cooperatives and pro-coop entities.

As of June 21, 2002, MSCB has converted into a national coop, with corresponding change of name to *Bangko Kooperatiba ng Pilipinas* (BKP), gone into intensified capital build up and membership recruitment, reached membership of 300 member-owner cooperatives from all over Luzon targeting next enlistment from every region in the Visayas and Mindanao. Following the steps of BBCCC which became the first member from Northern Luzon, the latest additions of members from the North are big names like SLU-SVP Housing, Baguio Savings, Philex Mines Credit, Baguio Maharlika, Tubao Credit, Baguio Market Vendors, Isabela State, Cagayan Valley Fed, Five Star Multi, Saranay Credit, and Lingayen Catholic.

Some big-time investors to the Bangko Kooperatiba ng Pilipinas (BKP) and what it stands and strives for are: PLDT Employees, San Dionisio Credit, PUP Credit & Hsng, UPLB Credit, ADB Employees, St. Martin of Tours KB, Barangka Credit, Parish of the Holy Cross, NCR-PFCCO League, NEDA Multi, Bulacan Fed, Central Bank Employees, Coop Trading Center, Landbankers Credit, Southern Luzon League, ACDI Credit, Soro-Soro Ibaba, Coca Cola Export, Pasig Parish, Dela Salle U Credit, Coop Bank of Pampanga, Bataan Coop Bank, Simbayanan ni Maria, Sacred Heart Parish, Baclaran Vendors, San Jose del Monte, St. Joseph Marilao, NCR Coop Union, Intel Credit, Phil. Navy Finance, Morong Retailers, & Xavier Credit.

Option 3 (CCFS) or Option 2 (BKP)? They don't clash. In fact, they can proceed side by side. Even Land Bank admits their involvement is temporary until such time that the coop sector is ready and able to take over, perhaps even acquire Land Bank itself. MSCB's initiatives and tough job to pull together cooperatives from all over prepares for mutual and public trust which leads to the facility for sharing and pooling of ideas, then sentiments, and ultimately the financial resources, information, and risks across cooperatives nationwide for expanded capital base and greatly enhanced but accessible professional financial server – BKP. The limit is indeed bordered by how much each coop is willing to give and abandon in exchange for the interest of the bigger whole, and in the long run, its own members. For itself and Philippine Cooperative Movement, the BBCCC has taken another step ahead.

GM Jess New RCBN Prexy

Congratulations to our General Manager, Jess, on his induction as the new president of the Rotary Club of Baguio North (RCBN). It becomes our BBCCC's pride that our GM heads this prestigious civic organization. Incidentally, GM Jess, is the second RCBN president from BBCCC. The first one was the late Chair Greg Rimas, who was responsible for recruiting GM Jess to the Rotary.

GM Jess was inducted into office in fitting ceremonies last June 26, 2002, at the Supreme Hotel by past Rotary District Governor Cez Mendoza. Chair Atong and Vice Chair Ampy attended the induction as guests of the new president.

The rich human resource of BBCCC transcends, indeed, beyond its four walls, and spills over to serve the community in the spirit of "we care that's why we share ourselves to fellowmen."

MEMBERSHIP NUMBER UPDATE

BBCCC keeps on growing as the months roll by. The twice-a-month Pre-Membership Education Seminars (PMES), scheduled on the first and third Sundays continue to attract many participants.

For the first quarter, January to March, the BOD approved four hundred and thirty-one (431) new regular members. For the second quarter, April - June, there were four hundred and thirteen (413) approved regular members. The total membership to date is 14,302 including associate members.

There have been a good number of withdrawals from membership, however. As in the past, the main reasons given for getting out include transfer of residence, transfer of work, loss of employment, inability to pay loans, and other allied reasons. Of a total of one hundred twenty-two (122) withdrawals for the past two quarters, 17 are allowed re-entry and the rest, 105 are not allowed re-entry. The BOD decides on the re-entry and no re-entry status of withdrawing members' based on the reasons given. One invalid reason for withdrawing is offsetting one's loan against the fixed deposit or share capital.

A look into the associate membership roll reveals a composite number of young savers consisting of one thousand sixty

The scholarship project, supporting 40 high school students-scholars at one given time, who are studying in Baguio and Benguet secondary schools is another BBCCC educational assistance program. It is now on its 5th year. Ten new scholars in first year are admitted every year. Screening is based basically on financial need and academic ability. All scholars are given a monthly allowance, modest but sufficient for their general needs. They are required to deposit a small amount of the allowance if only to inculcate in them the habit of saving. They are enjoined to attend a monthly educational activity - conferences, study trips, group dynamics, livelihood trainings - to complement their classroom work. The insights they receive enhance their growth and development towards responsible behavior. Graduation last March was a happy occasion to BBCCC. Not only did the first batch of BBCCC scholars graduate but among the ten was a valedictorian who also received a medal for leadership and for proficiency in Culinary Arts, a first honorable mention, an awardee for Values Education, and two graduated with honors. They make BBCCC proud and the scholarship program meaningful!

BBCCC Officers at NATCCO's 25th National General Assembly

Last May 25-26, 2002, four (4) BBCCC Officers attended NATCCO's 25th National Convention which was held at the Waterfront Hotel, Cebu City.

Those who attended were: President and Chairman of the Board, Atty. Renato C. Fernandez; General Manager Jess Cendaña; Legal Committee Chair, Atty. Nelson V. Gayo; Election Committee and member, Mario Valdez and SLU-SVP Managing Director and BBCCC Housing Committee member, Mary Minglana.

In sum, the seminar on coop housing emphasized that the future of co-operation in general, and housing co-operatives in particular, hinges on solidarity. It depends on the movements' ability to develop, to manage itself efficiently, to exert political and public influence, to train its volunteers and staff as well, and use its numbers to best advantage. While many housing co-operatives have successfully met the immediate needs of their members for shelter, they must also broaden their commitment to helping themselves and others through co-opération.

The success and the growth of the housing co-operatives movement is linked to the ability to co-operate and unite at all possible levels. Success and growth depends on the ability to share and gain from each other's experiences. Beyond the interest of individuals and co-operatives, expansion of the movement should be the major objective. The challenge is to research, examine apply and build on every possible opportunity to go forward and meet the broader aims of co-operation in order to achieve workable housing schemes for our people.

abate it. Lately we have started expelling from our roster those members whose accounts have matured and remained unpaid. This applies especially to those whose fixed deposits were higher or more than their matured loans. Our accounting office had effected off-setting of their matured loans and penalties against their existing share capital. Consequently, our Board of Directors had terminated their membership. We are also deputizing a collector very soon to pursue collections of those big accounts left unpaid. Our Legal Committee Chair Atty. Nelson Gayo is also working hand in hand with his members Atty. Zosimo Abratique and Atty. Bernard Padang in pursuing some collection cases filed in court. A list as well of our delinquent members is being prepared for publication if only to remind those concerned to update their payments. Other measures are being studied to maximize our efforts in addressing our delinquency problem.

Again we enjoin everyone to help and support our movement especially in the role of advocacy. While at present we number already more than fourteen thousand (including associate) still out there in our own neighborhoods or work places are others who have yet to know the concept of cooperativism and the great benefits that they may derive from it. Our number of membership compared to more than three hundred thousand inhabitants of Baguio population shows definitely a very minimal percentage ratio of coop exposure. Invite your officemates, members of your family, your neighbors, your relatives, your co-workers in the factory and help us make Baguio a Coop-conscious city.
