Is It Time For... the ICA Model of Housing Cooperatives? Atty, Renato C. Fernandez

At the prodding of the General Assembly of members, BBCCC has embarked into cooperative housing. Under the special provisions relating to credit cooperatives, one of the objectives of a credit cooperative is the provision of "related services to enable its members to maximize the benefits from such loans." Housing, like the grocery and rice bulk procurement, falls squarely as a related service. Loan application records to bear that swaying as now-first-now-second biggest portion of members' loan go to housing-related expenditures. Every family must have a shelter.

The known sector pioneer SLU-SVP Housing Cooperative has been engaged in the provisions of housing units "the cooperative way" since 1972. It has close to 300 housing units in its housing coop community in Bakakeng, developed in four phases. The housing concept it advocated with pride had been a model, for quite a time. Until it was overtaken by evolutionary changes within itself and the totality of new affective forces of the socio-economic and legal environments within which the housing coop operates. The model, it appears, has had its time. Despite efforts to do so, the precious elements that had made it a success among "best practices" have not been replicated. Even as SLU-SVP itself and its new breed of home-seekers have built and settled in approximates, strains of coop housing alternatives are nonetheless being daringly tested and concretized through five housing projects at Ambiong, Longlong and Puguis, all in La Trinidad, Benguet. And again, the winds of new environmental forces demand appropriate adaptations.

The Housing Committee of BBCCC, tasked to make available at affordable cost decent housing ti interested members willing to settle in a proposed BBCCC housing community in Lubas, Trinidad, has been closely monitoring these developments, including thorough scrutiny of alternative housing concepts. This new service arm is chaired by Atty. Ruben Copruz, with his rich experience as former HUDCC social housing project director and current SLU-SVP chair, who, just like Mrs. Maria Asuncion Minglana (for SLU-SV), Dr. Amparo Rimas (BBCCC), and Atty. Renato Fernandez (Coop Forum), had the opportunity as grantees of KF Project Center (Sweden) to study first-hand and be immersed live in the structure and operations of ICA model housing cooperatives and related support mechanism in northwestern Europe.

In this model, commonly tenants' owners cooperative, a member, is a part-owner of the organization and subdivision by contributing a share of the cost for building and operating the cooperative, and gets from the cooperative a certificate of eternal living right in the unit he lives in. such tenant owner can sell the part-ownership on the market, as if he owed the housing unit. The BBCCC project, as proposed, may pilot the scheme translated as projected, into detached dwelling units, row houses, or

of low-rise condominium buildings. Under the concept the units in the housing project are to be owned by the duly formed cooperative or cooperatives. Considering the success of this scheme in 50 countries under the International Cooperative Alliance Housing, perhaps the time has come, and BBCCC has to play a lead role, to end the trial-and-error solution to perennial housing and settlement problems.

BBCCC Joins NORWESLU in the Celebration of Cooperative Month

On November 22, 2003, BBCCC together with other primaries in Baguio joined NORWESLU in the celebration of Cooperative Month.

A motorcade opened the celebration starting from the Convention Center and ending at the Mabini Elementary School where educational sessions took place.

There were 4 topics for choice by the 71 participants. The topics were:

- Human Resources Development discussed by Dr. Ampy. Rimas
- 2. Risk Management/Delinquency by Mr. Rex Prendol
- 3. Good Governance by Dir. Gloria Bucaoto
- 4. Coop Pesos by Dir. Eric Calixto

The Chair Has Been Busy On His Feet Consultation Meeting with Electric Cooperatives

BBCCC chair Atty. Renato C. Fernandez had the distinction to be a member of the panel of speakers who presented their respective views on the nature, positioning and fate of electric cooperatives (ECs) then created by virtue of PD No. 269, as amended by PD No. 1645. The occasion was a national forum on electric cooperatives which was held on December 6, 2003 at the Hotel Rembrandt; Morato St., Quezon City. It was attended by officers and representatives of electric cooperatives all over the country, drawing mixed views and reactions, sentiments and proposals as to the true nature, ownership and treatment of electric cooperatives in the light of the provisions of the Electric Power Industry Reform Act (EPIRA) and recent jurisprudence.

The EPIRA gives electric cooperatives the option to convert into stock cooperatives [under the Cooperative Development Authority (CDA)] or stock corporations [under the Securities and Exchange Commission)]. A recent Supreme Court decision affirmed that electric cooperatives not duly registered under Republic Act 6938 are not exempted from paying taxes imposed under the Local Government Code.

Among the more active participants was Mr. Gerry Verzosa, general manager of the Benguet Electric Cooperative (BENECO), who shares Atty. Fernandez's view that electric cooperatives are and should still be associational, not profit-driven "stock" coops, and should therefore retain basic features like the ownership by member-consumers who contribute as they have contributed in the past, their shares of financial and social capital, plus adherence to the more equitable non-stock non-profit true-coop orientations in order to best serve its purposes of participatory, affordable and viable power to the grassroots.

Other speakers and facilitators were Mr. Geoffrey "Taps" Balce of the National Cooperative Movement, CDA Chair Ruben M. Comti, Sec. Rafael Coscolluela, Asec. Arthur B. Pinili, and Adm. Wendell Reyes, Adm. Virginia Teodosio, and Atty. Neil Santillan, all of CDA.

1st National Tripartite Conference for Cooperative Development

Close to six hundred local government officials, national government officials into cooperative development, and cooperative stakeholders from all over the country assembled and had workshops during a 3-day conference (November 26-28, 2003) at the newly-inaugurated Tagaytay International Convention Center in Tagaytay City.

The historic convergence by advocates and advocates-tobe aimed to draw for coop development under a tripartite body composed of CDA, in partnership with the Office of the Presidential Adviser on Cooperatives, together with the various Cooperative Development Councils as the coop sector's representative, and the Local Government Units and their coop development officers. More specifically, the coop practitioners drew framework for the formulation off a unified coop development plan and national agenda of the LGU's and to unite the provincial, city, and national cooperative develop officers under one national organization.

BBCCC chair Atty. Atong Fernandez was one of the conference resource persons having expounded in a plenary session on the peculiarities of Philippine cooperatives and presented the Medium Term Philippine Cooperative Development Plan which was earlier formulated jointly by PCC and CDA.

Updates On The Building Construction Works

By: Dir. Greg V. Andal (Liaison to the Board on Building Construction)

I am happy to report some events related to the BBCCC building construction which transpired as of the last reporting period.

Works on the foundation phase I, from earth moving, lay outs, footing, slabs pouring and beams are on-going. Earlier, the steel rebars delivered had been closely inspected by our construction team management for proper specifications. There were some observations and recommendations by our engineers as to quality which the contractor explained and responded satisfactorily. Also, the slight changes in foundation designs were justified, as our engineers requested, and contractor complied, with submission of design calculations, working drawings, details and cost estimates of the changes. Contractor assured that there were no notable changes nor variations as to the costs. Submitted by the contractor to our consultants and now on file are the following:

- 1. Copies of permit
- 2. Final structural plans and details
- CPM Network with respective duration of each activity, stressing critical path
- 4. Breakdown of activities
- Shop drawing of major items of work, signed by engineer or architect
- Reinforcing bar layout, cut-off points, splice points, etc. of structural elements
- 7. Pouring request forms

The contractor also provided as requested photocopies of government permits, from demolition, excavation, building sanitary, electrical, mechanical, and sidewalk occupancy. It is to be noted that the first pouring of cement was indeed a state of the art, by Theanna Development Company which utilized pumpcrete and transit mixers with zero intervals standby. There were mixture samplings collected and placed in cylinder molders, ready for testing. Results of test at the SLU College of Engineering are on file available for inspection anytime. Meanwhile, steel bars for phases 2 and 3 foundations are presently arriving. Monolithic pouring shall take place only when everything is already laid out, inspected, and with the consultant team's go signal. Pouring target date – one night and one day without break – is set on December 20, 2003

Ms. Dhel Sabedra (employed with BBCCC since Sept. 1967). "The late Mrs. Caridad Trinidad was the President when I came into the coop. Fr. Benedicto Jayoma and Mrs. Fanny Brillantes were my companions in the office. We were doing everything: recording, processing loans, collecting, etc. We were loan officers, loan collectors, secretaries; treasurers managers all at the same time. We would go to the market daily to collect from the meat and vegetable vendors. Already then, we had problems with delinquency but to a small extent because the members were few then at that time. The services were only loans including petty cash. The coop office transferred from place to place: from the Brillantes boarding house at Assumption Road to the Rillera Bldg, at Burgos where we shared space with the Acupan and Balatoc Mines Cooperatives; then for a short while to the Cathedral. Later we rented a room at the Resurrection Church Compound along Magsavsav Avenue,but finding it very far for our members, we went back to the Brillantes Apt. but it was very small and so we moved to an empty garage of the SLU priests. Then in 1988 the coop purchased the back part of Estepa Apts at very reasonable price and at affordable installment. A year later, the Brillanteses sold their building where the coop had its original office. It makes me extremely happy to see the coop progress so much and I thank the Lord for His blessings and graces in guiding the coop all the past years. I am proud to have been a part of the beautiful history of service of our Cooperative"!

Antonio Ramos - a former President of BBCCC (1971-1972) - "Loan amounts were small, we had to wait one or two weeks to get our loan because we were few and we there was not much money to circulate among the members. I remember my first loan, which I got from then President, Prof. Alberto Crespillo. I got an amount considered big during those times - P 800.00! It was enough for my wedding and honeymoon!!! With my succeeding loans we started to buy home appliances including our piano. From the MANAGER'S DESK......

No sooner than we realize it, December is with us. Just as we thought we have just commenced the fiscal year we now find it about to end. We wish to update you on some developments which came up since our last report in our third quarter issue.

Our operations are going on course. Seems like we are managing to meet the projections we have set for this year. Our statement of operation for the period covering January to September 2003 shows our income at P 48, 929, 815. Relating this amount with our projected income for this fiscal year (P 63, 429, 000) will show a 77% performance rating at the end of three quarters. Our total expenses as of September 2003 amounted to P 12, 052, 477 which manifest a 66% performance rating vis-à-vis our projected year expenses at P 18, 582, 100. Comparing our income with our expenses for the three quarter period gives us an undivided net surplus of P 36, 877, 339. This shows an 82% performance rating in relation to what we expect to attain by the end of the year in net surplus which is P 45, 071, 900. We are optimistic that with the remaining last quarter we will attain our year end target.

Our Coop has been honored last November 21-23. 2003 during the 2nd Century Coops Conference at the Island Cave Resort in Kawit, Cavite. This conference was convened for an exclusive group of cooperatives in the whole country with at least Php 100 million in net worth. Out of 60, 000 registered cooperatives nationwide, there are only twenty six (26) coops presently qualified to this Club. BBCCC is honored to be on of them. In fact we ranked second in terms of net worth. The Philippine Army Finance Center Producers Integrated Cooperative tops the list with Php 597, 915, 687 in net worth. BBCCC has a net worth of Php 336, 135, 365. PAFCPC has a total membership of more than 37, 000 while BBCCC has only around 15, 000. PAFCPC is an institutional type of coop while BBCCC is a community type of cooperative. Under the community type category then we rank first among the rest in the whole country. Our high net worth can be partly explained by the fact that we owe not even a peso from any outside financial institution. We are solely operating on our own members' equity revealing the real self reliant character of our organization.

We are gradually progressing with the computerization of our different accounts. After computerizing our savings deposits account we are now in the process of integrating into the computer system our fixed deposits accounts. Please do not fail to request for your new Savings Deposit Passbook (Green Color) from your respective Accounts Clerk if you have not secured it yet. The other passbook which will be issued you is the Fixed Deposit Passbook (Red Color) the next time you transact business with the office. Please bear with our personnel if initially it will mean a little time for them to prepare and process your passbook as they are still getting used to the system. As they familiarize themselves with it they will be able to

serve you better in the future.

The Environmental Compliance Certificate (ECC) we have applied for from the DENR (EMB) has finally been issued last week. This document we have been anticipating is necessary for the processing of our Development Permit to be issued by the Municipal Government of La Trinidad. Once the Development Permit is granted we may

finally commence site development of our Lubas property. Meantime, we have initially started the widening of our access road leading to our Housing Project. This will provide convenience for our heavy equipment easier access to the site when our ground works begin.

From Repacker to Factory Owner

Such is the drama in the life of Clemente Salabit, 43 years old, and 16 years member of BBCCC.

He remembers fondly the humble beginnings of his STAR CHIP PRAWN CRACKERS business. "I was only a repacker – repacking practically everything – butong pakwan, peanuts, fish crackers, prawn crackers, etc. I would get the big sacks from Bulacan, bring them to Baguio through a "back load" arrangement with my vegetable dealer friends who bring their vegetables to Manila and who have no load when they returned to Baguio. After repacking, I would distribute the small bags around the city – to school canteens, to restaurants, to sari-sari stores – on my motorbike, "dalawang gulong limousine" I would call it.

Finding repacking tedious and distributing laborious (I could carry only only so much per trip), if not dangerous, I longed to "graduate" into producing the goods myself. But I had no big money for capital. In my predicament, BBCCC readily came to my rescue. I started to borrow amounts within my capacity to pay. The more often I borrowed, the bigger my share capital became due to the coop's beautiful system of "in-built-capital build-up" where a percentage of the loan goes to the share capital. With the numerous loans I made, I put up a small factory in Manaoag. I also was able to purchase a second hand jeep, which this time I called my "four-wheel limousine" - to distribute my goods around, putting my motorbike to the "souvenir" department. Life wasn't easy even at this stage: I was the marketer of the materials and ingredients I needed, I was the cook, I was repacker and I was driver and delivery boy. However, this time, I could be called "manager" and this sounded heavens to my ears!

Then tragedy struck. His factory burned. A man of lesser stuff would have been totally devastated. But Mr. Salabit took it as a challenge. One bad day is not the end of the world he reasoned out. With help from friends, he scouted for another place to relocate his factory. It was in Agoo this time. He purchased a two-hectare lot, through loans from BBCCC, where he put up a bigger, much better equipped factory. His big lot also enabled him to diversify. He put up fish ponds and a piggery. As if to test his mettle, a second tragedy struck. Thieves victimized him of ready-to-harvest tilapia, bangus and shrimps of almost half a million worth. But just like in the first tragedy, he was undaunted. Instead, he courageously stood up very confident that "in my hour of need, BBCCC is there to lend a hand!" While his amortizations were affected, he would be able to recover, he says, with renewal of loans.

His prawn factory, piggery and fish ponds have given jobs to a member of people and this indeed makes him a participant in the government's job-creation program. At the same time, he is exemplifying the BBCCC objective of "improving the quality of life of our marginalized population."

With Elf and vans to distribute his goods around, Mr. Salabit enjoys good market not only in La Union but also in Pangasinan and upward Ilocos. His wife, Virgie, helps him supervise

"Make Every Loan You Take Productive"



Celia Navarro, coop member for 16 years, remembers with nostalgia this advice of the late Chairman Greg Rimas. "See to it that you borrow only when you need to and when you do make sure that your loan will serve productive purposes", Celia quotes "Sir Greg" as she fondly calls Mr. Rimas. This advice has guided her since in every loan she took. No wonder that her business, which consisted initially of peddling tupperware, RTW and ladies wear to parents of school children turned into a very big and lucrative business.

"I did not have space to sell my goods, I couldn't afford to rent one" she said of her early years as a businesswoman. So when I became a member of the coop, I loaned an amount which enabled me to rent a space in the public market where I sold grocery goods. My next loan enabled me to replenish my stocks. The next loan enabled me to rent another space where I put up computer and xerox services and where I sell school supplies. Business here is very good because it is near a school. My investments were paying off handsomely, My loans are very productive indeed.

I turned next to buying a piece of land to build my house. I got a loan of P 300, 000 from the coop and got a lot from SLU-SVP housing project. Modesty aside, I have paid my amortizations well ahead in advance and have fully paid the cost.

"The coop taught me to discipline myself". Whenever I borrow, I know I have to pay it back, on time and in the full amount as indicated in the amortization schedule. I do this every time and because I have good record, I never had any problems with my succeeding loans.

"I am so very grateful to BBCCC for my life now. My husband and I live comfortably well. My 2 daughters are through with their nursing studies and my businesses are doing great. God bless BBCCC for giving me the break in our life."

the BBCCC compared with other multi-millionaire coops in the country. The basis of the study were their financial statements as of December 31, 2002.

IN TERMS OF NETWORTH. Overall, the BBCCC ranked number 2 in terms of the owners'/members' investment in the cooperative, with a total Networth of P336,135,365. The first is the Phil. Army Finance Center Producers Integrated Cooperative (PAFCPIC) with a total networth of P597,915,687. BBCCC, however, ranks number 1 for the community-based type of cooperative. PAFCPIC is an institutional based credit cooperative.

IN TERMS OF ASSETS. BBCCC ranks no. 6 compared with the 26 outstanding coops. The total assets as of Dec. 2002 was P432,492,731. Again, PAFCPIC ranks No. 1 with assets of P1.2 52 billion pesos, followed by ACDI Credit Coop with assets of P1.198 billion pesos. Both are institutional based coops. Compared with community based coops, BBCCC ranked no. 3 after First Community Cooperative of Cagayan de Oro with assets of P744,065,000 and Perpetual Help Community Cooperative of Dumaguete City with assets of P535,367,000.

IN TERMS OF NET SURPLUS. The BBCCC's 2002 net surplus of P41,902,316 placed it at number 5 overall standing but number 2 in terms of community based cooperatives, second to FICCO with a net surplus of P49,425,949. Our Surplus Margin of 73.3% made BBCCC number 1 and in terms of Return on Assets (9.7%) BBCCC ranked number 2, next to the Asian Development Bank Employees MPCoop.

IN TERMS OF SIZE OF MEMBERSHIP. The 2002 year end membership strength of 14,046, placed the BBCCC as number 5 overall, but number 3 among the community based cooperatives with FICCO as number 1 with 38,069 members and PHCCI with 18,390 members.

BBCCC'S BEST PRACTICES

shared the coop's best practices. They gave emphasis to the Grocery Bulk Purchasing Services for the members and the cost-sharing scheme adopted for the transport, lodging and other facilities of the cooperative. The capital build-up scheme which generated millions of share capital/fixed deposit in a quarter was also shared including the savings mobilization program involving the children/grandchildren of members. They said that these twin programs are the reasons why the coop does not borrow from external sources. They did not, however, forget to mention that the position of BBCCC in the coop industry is mainly because of the contribution of its dedicated volunteer cooperative leaders, efficient management staff and vigilant membership.
