

et me begin this message by greeting everyone a Happy and Bountiful 2015 ahead of him or her!

Before the year 2014 ended, your BBCCC officers and heads of the staff met to plan out 2015 well ahead of time. It was a Strategic Planning Session of a novel sort. We did not start with new programs but evaluated seriously the programs that we initiated for the year with such evaluations based on the results of an extensive monitoring program that saw focused-teams comparing the progress of special programs on a quarterly basis. The monitoring teams were themselves institutional or structural innovations. Each was composed of an officer, an employee, and a regular BBCCC member. It was meant therefore to be participative as well as comprehensive and the results of the monitoring they conducted served to correct, realign, and revitalize programs that have suffered from slow or inappropriate implementation as well as to sustain those programs that have well taken off.

The strategic planning meeting aimed to connect the tactical plans of the various committees and departments with their strategic plans, taking very careful heed of the global finding that 60% of organizations fail because of the lack of planning. It also took into consideration the findings and recommendations of our External Auditor, Mr. Christopher Ismael, in his audit of our operations for 2014.

Now, based on these considerations, our strategy of an AG-GRESSIVE INVESTMENTS MODE (AIM) for 2015 should be hinged on four principles: RECOUPMENT, that is catching up on some ground that was lost; INNOVATION, to offer new ways to mobilize capital and to finance our operations without however abandoning the important elements of our cooperative identity;

# **ASEAN Integration 2015: Is the Philippines Ready for AFTA?**

here is simultaneous happiness and unease over the ASEAN Free Trade Agreement (AFTA) or its more recent transformation into ASEAN Trade in Goods Agreement (ATIGA) and ASEAN Framework Agreement on Services (AFAS).

These are the heart of the ASEAN Economic Community for which a mindset change of stakeholders is needed to face the end- 2015 economic integration deadline; these include politicians who have to implement agreements committed and signed by the government, business leaders who ask for protection and preferential treatment instead of proactively addressing long-term problems, and the general public who must wage a continuous battle against corruption and inefficiency.

Fears over changing comparative advantages, bad environments of doing business, more complex and chaotic

global conditions, etc. must be balanced by careful exploitation of opportunities.

The Philippines has its own strengths going into AEC 2015, e.g., governance improvements that led to stronger economic fundamentals and investment upgrades, and network of overseas Filipinos who bring information on markets, financing options, transferable technologies on top of continued foreign exchange remittances.

It could overcome its weaknesses by pushing for more reforms in investment/ trade promotion and facilitation by:

- Automating business procedures in national government agencies; streamlining procedures across various offices, and making them more transparent and consistent;
- Unifying various investment promotion bodies and adopting PEZA operation practices, harmonizing their

incentives, reviewing the Constitutional 60-40 rule on foreign equity participation and other limitations; and

• Instituting a national single window and linking its databases with the Bureau of Customs to improve risk management; instituting egovernment with sufficient physical and human infrastructure.

The Philippines should also pay attention to its much neglected physical ports facilities through PPP, remove conflict-of-interest in regulatory agencies that own certain infrastructure, review its cabotage policy, and improve the efficiency of regulatory agencies and trade-related offices.

The ASEAN Political-Security Community and the ASEAN Socio-Cultural Community do not receive as much attention but serve as foundations for the economic pillar of the integration exercise in Southeast Asia.

Issues such as drug trafficking, labor migration, a peacekeeping force, strong mechanism for enforcing human rights, and border issues among member states and with China on maritime waters do affect the progress of the ASEAN Economic Community. Local and foreign direct investments, as well as government expenditures, are swayed in certain locations and industries according to perceptions on these matters.


s Gender the same as Sex? These terms were given clarity on a seminar about Gender Sensitivity on Cooperatives held at CAP Auditorium last October 11, 2014 sponsored and conducted by NORWESLU with BBCCC Director Oscar R. Adversalo as the Resource Speaker.

BBCCC had 10 participants namely: Luisa Elvira Coloma, Farah Salud Hidalgo, spouses Juanito A. Nastor Sr., and Gloryve Nastor, Pre-school teachers Cherry Pie Lengwa and Isabel Lynden Huag, Senior Citizens Florenda Vergara and Mercedes Fiesta, and from BBCCC Olive Joy Lacanaria (satellite office staff at LTB) and yours truly.

The topics discussed on the seminar are Gender Concepts, Gender Roles, Gender Stereotypes & Scripts, Gender Socialization, Gender Issues and Household for communities, Gender Equality, and Gender Mainstreaming in Coops.

I was enlightened about the difference between SEX (male or female) and GENDER defined as differentiated social roles, behaviour, capacities & intellectual, emotional & social characteristics attributed by a given culture or community to men or women.

Significant points about Gender Equality was discussed leading to the awareness and understanding that men and women are equal and that they are just different because of biological differences but there are duties, errands, responsibilities and tasks that a man and a woman can do



or perform interchangeably, actively, effectively, and efficiently thus eliminating and getting rid of discrimination, abuse, and violence among women.

Mr. Adversalo gave some examples of applying Gender Sensitivity in the workplace. The most thought provoking part of the seminar is about the topic on Gender Issues and Household for Communities.

The family is the most basic unit of the society and it is where an individual is moulded ,thus if an individual is aware of Gender Sensitivity, it would not be difficult for him/her to apply and to influence to transform others and his/her environment.

I was moved and touched with the video presentations which were very much linked and inter-related to the seminar. As a response, we were all called to make a pledge and a commitment on how we can apply what we have learned in the seminar, a commitment to make a difference starting with ourselves in the family,

in the workplace and in the community.

Men and women must work hand in hand to accomplish a break through, something meaningful, beautiful and fruitful.

As the Scripture says: Genesis 2:18 Then the Lord God said, "It is not good for the man to live alone; I will make a suitable companion to help him." ## What is AFTA 2015?

y now, the ASEAN Free Trade Area (Agreement for some) or AFTA 2015 concept may have hopefully permeated every Filipino's psyche and consciousness. This is a very important event that everyone must be aware of and understand. Otherwise, its impact and repercussions may hit us like a speeding truck and leave us sprawled on the ground dumbfounded and confused.

For those who may have already forgotten what AFTA 2015 is all about below is a brief description.

The AFTA was signed on January 28, 1992 in Singapore by the ASEAN heads of state and governments. The original signatories include representatives from Brunei, Indonesia, Malaysia, the Philippines, Singapore and Thailand. Vietnam joined in 1995, Laos and Myanmar in 1997 and Cambodia in 1999.

The objective of this agreement is to increase the region's competitive advantage as a production base with the end goal of penetrating the world market. Also included in the objectives were to encourage more foreign direct investments to the region and to liberalize trade through the elimination of tariffs and non-tariff barriers among the ASEAN members to 0-5%. This means that the agreement is expecting a fixed period of downward preferential tariff adjustments until those tariffs come down to zero.

Once implemented, this will expand the intra-regional trade allowing the ASEAN consumers wider choice and better quality consumer products.

However, before the plan can be implemented it is imperative that each country of the region must have seamless coordination and integration in

terms of common processes and systems. In the field of education for example, among the many reasons why the K+12 Program of the Department of Education (DepEd) and the shift of the tertiary level school calendar were implemented were to synchronize our educational system with the rest of our neighbors. Thus, students can enroll in schools and universities within ASEAN without much hassle and interruption.

The target date of implementation of the agreement will be this year 2015 especially for the six original ASEAN member countries. While for the newer member-countries, the target date of implementation will be by year 2018.

In the cooperative movement where we all belong, there is a growing apprehension especially among the production and agricultural-based cooperatives. It is perceived that this intense competition from the ten ASEAN neighbors will open the doors and allow the entry into the country of cheaper agricultural products. Aside

from this, the free flow of other products like electronics, semiconductors, garments among others will imperil our country's export capacities.

Credit-based cooperatives like our BBCCC might also encounter stiff competition from foreign banks and other financial institutions. War on this front will be waged on better interest rates and other offerings meant to attract customers. The question that bears deep thought is how these local organizations and even co-ops can compete with our ASEAN neighbors that have long practiced better production system and more sustainable business models.

The ASEAN or the Association of Southeast Asian Nation is a political and economic organization that was formed on August 8, 1967 by Indonesia, Malaysia, the Philippines, Singapore and Thailand. Indeed, AFTA 2015 is now upon us and knocking at our doors. Are we really ready to welcome it?

# **Co-op Research Group and BFI Institute Gave Training to High School Scholars**









s its contribution in the development of the youth, the BBCCC Research, Development and Publications Committee (RDPC) in partnership with the BBCCC Foundation, Inc. (BFI) and the BFI Institute of Cooperative Skills, Development and Education (ICSDE) organized last November 8, 2014 a seminar/training meant for high school students.

The first training was on "How to Conduct Proper Internet Research" and the second training was on "Leadership for the Youth".

Invited to attend the training were the current 40 high school scholars sponsored by BFI.

The scholars were welcomed by BFI Executive Officer, Prof. Jopo Andaya. The first module saw RDPC member and SLU professor Gabby Pinas talk about the value of submitting properly

documented research outputs to their teachers and to not just rely on "cut and paste" practice.

Prof. Pinas said that as early as high school the proper research skills must be practiced because it will be very helpful once they become college students.

This talk was then followed by RDPC Chair, Robert Belda who gave tips on how to conduct basic yet academically approved researches using the latest technology. Mr. Belda discussed with them how to use search engines, the parts of a web page, different types of web pages/web sites, evaluating web sites for credibility and how to assess the information contained in those web sites.

The next topic discussed for the day was about "Leadership" and this was handled by recent Political Science graduate and current Institute Research Assistant Jhomar Doriano.

Mr. Doriano discussed about the importance of developing the qualities of a good leader. He said that as scholars of the Co-op, they are duty-bound to always lead by example so that their classmates and other students will emulate them.

Dr. Mario Valdez, BFI Scholarship Committee Chairman and RDPC member, said that the training allowed the students to gain valuable insights on the aspect of research as well as the value of leadership. These skills, Dr. Valdez added, will help them navigate the more complex world of college life in the near future.

Similar seminars and trainings are now being planned for other Co-op members and their dependents to attend. Schedules of these seminars/ trainings and other details will be posted on the Co-op's bulletin boards.

ADAPTATION, to hone our competitive edge vis-à-vis a more aggressive banking and finance sector; and PRAGMATISM, to effectuate a more flexible and practical application of the cooperative principles in order to create new opportunities for growth and prosperity, offering new ways of achieving the cooperative promise and potential.

Thus, through AIM we want to come up with innovative ways to address the dual roles of the cooperative member as investor and borrower and to dispossess our minds of the false duality between member-investors and member-borrowers. By encouraging the member-borrower to go more for productive rather than providential loans and the member-investor to borrow for productive ventures either individually or with the Cooperative as partner-producer, we can empower our members to be not only MEMBER-INVESTOR or MEMBER-BORROWER but AS MEMBER-BORROWER-INVESTORS!

In this regard, our pivotal strategic areas should include harmonizing members' interests and the cooperative's interests as the key to AIM. Our strategies and tactics should focus not only on improving operational efficiency and increasing member patronage but also on empowering "member-borrower-investors." We should promote increased member patronage so that it encourages member investments through our cooperative. We should always keep in mind that cooperative capital formation is essential for corporate growth and that member capital formation is key to their own empowerment. In sum, the BBCCC should innovate in the development of its business and in particularly in its lending strategies and methods.

Lastly, we should dispel the notion that the NET SUR-PLUS is absolutely equal to the bottom line in our operations. The net surplus is actually larger than the so called net profit since part of the net surplus has already been advanced to the members through members' insurance benefits and medical/dental services, Christmas gifts and tokens, Family Day food, gifts, and prizes, General Assembly meal allowances, reduced borrowing costs, enhanced member services, and other members' benefits and opportunities.

Thus, the COOPERATIVE'S NET SURPLUS is measured not only in financial or economic terms but also in how the Cooperative and its members grew beyond their current capacities individually and as a SOCIAL AND POLITICAL COMMUNITY during the period in question.

# BCCDC General Assembly Held, Adversalo Elected 2015 Chairman

he Baguio City Cooperative Development Council (BCCDC) held its fourth General Assembly (GA) meeting last December 6, 2014 at the Cooperative Development Authority – Cordillera Administrative Region (CDA-CAR) office, Magsaysay Ave., Baguio City.

During the said meeting, BBCCC Vice Chairman, Oscar Adversalo was voted as BCCDC Chairman for year 2015. Also voted during the annual activity of the Council were: Mr. Ruperto Ferrer (Vice Chairman), Ofelia Valencia (Secretary), Brenda Navalta (Treasurer) and Joseph Del Rosario (Auditor). Completing the officers of the BCCDC were: Ms. Felicidad R. Cenon, Co-op Devt. Specialist II and Mr. Romeo M. Denis, Co-op Devt. Specialist II (both representing CDA-CAR), and Ms. Michelle B. Agbuya, Community Affairs Officer (representing the city govt.).

The GA proper started by 9AM with Ms. Cenon of CDA-CAR presiding over the meeting. BBCCC Director and outgoing BCCDC Vice Chairman, Dr. Mario S. Valdez in his opening remarks welcomed the participants and enjoined them to actively participate in the day's activities which include: strategic planning workshop, review and approval of the Manual of Policies and the Code of Ethical Standards, and clarifying the role of BCCDC in the cooperative movement of Baguio City.



Dr. Valdez also mentioned that "... where there are many member-primaries in an organization like the BCCDC, other Co-op leaders should volunteer to lead the organization by being an officer of the Council in the pursuit of service to members. They must likewise share their expertise, experience and success stories of their respective primaries in planning and implementing future activities of the Council."

The outgoing Chairman, Dr. Placido Abuan reported that there are 129 cooperatives who responded to the program of the Council last year. He also reported that the council participated in the Cooperative Regional Month Celebration held in Abra last October 28-29, 2014. Most notable, he said was the drafting of the Manual of Policies and the Code of Ethical Standards which will be turned over to the new set of BCCDC officers.

Overall, BCCDC as a secondary cooperative of Baguio City is poised and ready for 2015 to take on more leading roles in the pursuit of cooperative development and progress.
