The National Cooperative Development Council (NCDC) in partnership with the Provincial Cooperative Development Council (PCDC), the local government of the Province of Palawan and in coordination with the Cooperative Development Authority (CDA) jointly hosted the 3rd Philippine Cooperative TEAMshop on November 11-13, 2011 at the Skylight Convention Center, Puerto Princesa City, Palawan.

"Philippine Cooperatives: Building Strategies in Response to Globalization" was the theme of the event. It sought to address the fast changing demands of our competitive world and the growing concerns of the effects of climate change. The cooperative sector became more aware of such issues and consolidated its resources to be able to respond to such challenges.

In the TEAMshop, the state of the cooperative movement in the Philippines, the legislative framework on cooperative developments, and the launching of the "UN Declaration of the International Year of Cooperatives 2012" were discussed and given attention on the first day.

The following day, the demands and challenges of the International year of the cooperatives were given emphasis. Further, global trends and model innovation/product branding and strategic response to global climate change were highlighted.

Finally, the three point agenda, the strategic road map and the challenges of "cooperativizing" the electric power industry were underscored. •

The courses/trainings to be offered by the Institute shall cover modules related to: Cooperative Formation, Institutional Development, Cooperative Linkages and Operations (i.e. accounting, finance, marketing, production/manufacturing, overall cooperative management, how to manage coop committees, among others).

The "big brother" concept will be utilized as the Institute seeks to help and assists struggling and even established cooperatives become more sustainable and progressive.

Speakers and facilitators will be sourced internally (BBCCC officers and staff) as well as from outside talents like established coop leaders and coop practitioners.

Its launching activity for 2012 will be the "Cooperative Leadership and Social Responsibility Seminar/Forum". This seminar is part of the 2012 Cooperativism as a Life Course Seminar Series.

This will be held on **Feb. 11, 2012** at the BBCCC seminar hall. A registration fee of P200 per participant will be collected to defray the cost of snacks, lunch, seminar kit and a certificate.

Learning to Become an Effective Coop Educator

I recently attended a seminar meant for the department heads and officers of the BBCCC last Nov. 7-8 at the BBCCC seminar hall. The seminar is called "Educators/Trainers Training 1: The Social Context of Education and Training". This was facilitated by Mr. Rodolfo Villanueva, a noted coop leader and lecturer from NATCCO Network Visayas.

The seminar is about teaching future coop educators/trainers on how to present lectures properly and what are the skills needed in order to be an effective and efficient coop educator/trainer.

My department head waived her right to attend the seminar and instead asked me to sit in her stead. On the first day of the seminar, I have no idea on what to expect on the content as well as with the facilitator whom I noticed to be very casual in the manner of dressing and demeanor.

The speaker/facilitator, Mr. Villanue-va to my surprise is very knowledge-able about the topic he discussed. That is the reason why I listened attentively to his lecture from day one which I find very entertaining (due to his lively powerpoint presentations) and very informative.

As a future coop trainor/educator I have learned that it is no easy task to prepare for a topic. It is my responsibility to leverage and use recent technology in order to make my participants alive and not feel sleepy.

The use of animations and music to enhance my powerpoint presentation for example is needed if I want my lecture/talk to be really interesting and lively.

The other important lesson I have learned in this seminar is that we have to master our topic. Mastery of the subject matter means that you have understood your material well and therefore can explain it in a manner that your participants can easily understand.

The other realization for me is that as educators and trainers we have to make the necessary connection to our audience.

One way is to look the audience in the eye. Also, we must always use the available spaces by walking around. We should also remember that we should not hold the microphone very close to our mouth as we speak. The microphone should be at least an inch away from our mouth.

Overall, as I assessed this seminar, the saying "Don't judge a book by its cover" applies in this instance especially as regards Mr. Villanueva.

He maybe very casual and unassuming but deep within, his knowledge of the subject matter and vast experience in the cooperative movement helped me understand my role at BBCCC and the whole cooperative movement better.

The Legal Committee (LC) is going strong in its objective to cause or facilitate extra judicially or judicially the collection of delinquent accounts of members as well as serve as legal advisers and/or legal consultants of the cooperative.

This year 2011, the LC already transferred five (5) foreclosed properties located in different parts of Luzon in the name of BBCCC and has filed thirty four (34) small claims cases plus other legal actions. These achievements show that the LC is serious in its work.

LC as stated above serves as legal advisers and/or consultants of the cooperative, it assist members to have an idea on how to pay long past due accounts/obligations, like the filtering/counseling services done every Saturday for members that are willing to settle their past due accounts with the BBCCC.

When accounts are being referred to the LC, members should not be afraid. It is not a villain or a monster that will eat you alive. Members will be surprised to find out that the LC is like an angel that is always there to serve and guide members.

LC is trying to reach the "impossible dream" that is, "A BIL-LIONAIRE COOPERATIVE WITH ZERO DELINQUENCY RATE", it sounds impossible but remembering the song... I Sign Therefore, I Am

If you have one of the six remaining documents containing the original signature of William Shakespeare then you need not bet at the lotto outlets because that would be worth \$5M or in pesos approximately Php215,000,000.00.

Quite a lot of money for a signature. The signature of Abraham Lincoln in the document where he defended the Emancipation Proclamation is valued at \$748,000.00.

Though lawyers are not William Shakespeare nor Abraham Lincoln nor John Lennon, still we pay so much for his signature to be affixed in a document.

In 2004 the Supreme Court promulgated AM No. 02-8-13-SC or the 2004 rules on Notarial Practice which has for its purposes, the protection of public interest, simplification and modernization of rules governing notaries public and foster ethical conduct among notaries public.

The document signed and sealed by the notary public would certify that the signature appearing therein belongs to a person who appeared before him; acknowledged the signature and the document is a voluntary deed and act or otherwise to the truthfulness of the contents.

The person appearing is personally known to the notary or otherwise identified by him by competent identification usually a government issued ID with picture and specimen of the signature.

Thereafter the document is no longer a mere piece of paper with inscriptions but one with legal consequences. Unless proven otherwise, the document is considered duly executed.

There are documents which do not necessitate the intervention of a Notary Public. However, they are no less important. This should be the attitude of one who signs any document or paper.

When a member signs a loan application as co-maker, it should not be treated as a mere scribble of a name but one with serious consequences. So that when the principal borrower is unable to pay, the co-maker becomes liable. He could not complain that he signed to accommodate a friend or that he did not receive any money.

This should not however discourage one from being a co-maker. Rather it should carry a responsibility and obligation to assist the coop reduce delinquency.

Prudence in signing any document is the call of the day. It does not stop with the signature. For his sake as co -maker and for the sake of the coop, he should monitor and remind the principal borrower of the obligations to pay. Your signature is valuable.

Even for a celebrity like Manny Pacquiao, whose signature is given out most easily, value is attached by the autograph solicitor to the signature. He receives a part of the celebrity.

I sign therefore I am!

Cooperativism in the Philippines, Today and Beyond

The cooperative movement is indeed in the upswing here in the Philippines. Not only are there more people who are members of a particular cooperative but more people are now aware that there are actually cooperatives in active existence these days.

These are operating cooperatives which can actually buy a fledgling corporation or a struggling bank and turn these into profitable enterprises just because they have the necessary capital and technical expertise to do so. Cooperatives these days have assets that run into billions and included in these so-called elite billionaire cooperatives is our very own BBCCC (P1.1B as of Dec. 2010).

The latest data of the Cooperative Development Authority (CDA), the government agency in charge of overseeing the cooperatives in the Philippines, revealed that from January to December 2010 there are a total of 13,033 new cooperatives alone registered under Art. 144 of RA 9520, bringing with it 3,969,402 new individual members in the cooperative movement.

When these figures are added to the 2009 data of the CDA, it can be gleaned that our country now has a total of 36,869 operating cooperatives with a total membership base of 9,825,476 individuals. This figure is roughly 18.45% of the 2010 population of the country 20 years old and above (53,253,300).

The population penetration can be interpreted two ways, it can either mean that cooperative leaders did their homework and increased the membership base year-on-year or that there are more work to be done considering that we still need to con-



vert 81.55% of the population 20 years old and above to join the cooperative movement.

The main objective of the movement is to help poor people free themselves from the bondage of poverty. And the more people who will join true cooperatives will also mean attaining more dignified lives especially for those living in the rural areas where basic services are hard to come by.

Cooperatives provide hope to the hopeless and help to the helpless. People need not wait for the dole outs given by the government which is sometimes long and hard to come by. By voluntarily organizing themselves, equitably sharing in the capital and actively participating in the services the cooperative offers, they can become proactive and productive members of the community.

Urban dwellers can also benefit by not relying on loan sharks who charge extremely high interest rates for loans. Cooperatives can easily extend loans to members who need them at easy and affordable payment terms One such type of cooperative proliferating in the urban centers are the workers cooperatives. According to noted economist Dr. Bernardo Villegas, "through a workers cooperative, the members are enabled to render work or labor as the product, service, or business thereof and in return not only do these individual members earn from their own labor, but they also benefit from the labor or work of the other members."

The importance of cooperatives can likewise be assessed if we look at the contribution of the movement to the country's gross regional domestic product (GRDP). GRDP measures the goods and services produced in each of the geopolitical regions of the country. For the fiscal year (FY) 2010, the cooperative movement contributed 5.86% which is an improvement to FY 2007's 5.14%.

Here in the Cordillera Administrative Region (CAR) where Baguio City belongs, the same CDA data revealed that there are already 247,487 members of cooperatives which is 25.91% of the CAR population 20 years old and above (2010 estimates).
